Thank you for your interest in becoming a Trustee of the Helen Bamber Foundation Group at either Helen Bamber Foundation or Asylum Aid.

This is an exciting time for the Helen Bamber Foundation Group as we continue to grow our impact and strengthen our services for survivors of torture, trafficking, and human cruelty and those seeking protection. Our work is more crucial than ever, as we advocate for vulnerable individuals within a challenging and evolving global landscape.

This year, we are looking to find five inspirational Trustees to join the Group supporting Helen Bamber Foundation and Asylum Aid, comprising three new Trustees for Helen Bamber Foundation and two new Trustees for Asylum Aid. We are also looking for one of those new Trustees to sit on both Boards.

At Helen Bamber Foundation we are looking for three trustees with experience in one or more of the following areas: policy, advocacy, public affairs or strategic communications; clinical or therapeutic experience; or human rights expertise.

At Asylum Aid, we are looking for two trustees with experience in one or more of the following areas: finance and accounting or someone with lived experience of being an asylum seeker, refugee or having sought another form of humanitarian protection in the UK, or of statelessness.

As a trustee of Helen Bamber Foundation or Asylum Aid, you will be part of a small team of volunteers who are collectively responsible for developing and guiding the strategic direction of the organisation and steering the long-term stability of your charity.

OUR HISTORY AND PURPOSE

The Helen Bamber Foundation, founded in 2005 by the pioneering human rights advocate Helen Bamber, was created to reflect the evolving global patterns of violence and persecution. Helen Bamber, who entered Bergen-Belsen Concentration Camp in 1945 as part of one of the first rehabilitation teams, recognised that all survivors of extreme violence – regardless of the perpetrator – require safety, legal protection, and medical and emotional support.

Today, the Helen Bamber Foundation's unique Model of Integrated Care (MoIC) provides holistic support encompassing therapy, legal advocacy, medical treatment, and practical assistance, helping survivors rebuild their lives with safety, freedom, and dignity. Using our expertise we drive best practice and systems change to deliver for all survivors.

In 2020, **Asylum Aid** (established in 1990) joined forces with the Helen Bamber Foundation to form the Group. Asylum Aid specialises in providing legal representation to vulnerable individuals seeking asylum, focusing on the most complex cases including survivors of trafficking, children, and stateless people.

Asylum Aid is a leading actor in strategic litigation and advocates for policy and systemic changes to remove barriers to protection and justice. Asylum Aid maximises its impact by providing training and working in partnership with other organisations.

OUR STRATEGY

In 2025/26, HBF Group are committed to:

- Increase the number of survivors to whom we provide direct support, and build capacity in the sector to provide quality legal advice and effective trauma treatment that works and prevents retrafficking
- Partner with more organisations and charities to increase the support available to survivors in the UK and increase collaboration with grassroots and lived experience-led organisations
- Use evidence, expertise and legal challenges to secure policy changes and reduce the impact of harmful systems on the mental health of survivors

FINANCES

In 2023, our total Group income was £3,777,377 while expenditure was £3,469,378 resulting in a surplus of £307,999. Our Total Unrestricted funds were £1,682,389. The Group employs over 75 staff and works with over 100 volunteers, including lawyers, doctors, therapists, artists, and other specialists.

Dame Emma Thompson is President of the Helen Bamber Foundation and, in her role, is an inspirational ambassador of HBF's work. Dame Emma Thompson plays a critical creative and advisory role, including curating the annual Conversation Event.

GOVERNANCE STRUCTURE

The Helen Bamber Foundation and Asylum Aid are each governed by their own highly skilled and dedicated Board of Trustees (with some commonality of Trustees), which provide strategic oversight. Our governance reflects our commitment to ensuring survivors' voices are heard through the inclusion of two Trustees with lived experience on the Helen Bamber Foundation Board. Both Boards have also committed to including Lived Experience Board Advisers on the Boards and we will be recruiting Asylum Aid's first Lived Experience Board Advisers later this year, as well as replacement Board Advisors for the Helen Bamber Foundation's Board, following a successful first term for two Lived Experience Board Advisors at HBF.

Boards are informed by a Terms of Reference which provides details on Trustee responsibilities and a Code of Conduct that guides our behaviours.

The charities operate with robust committee structures:

- Finance and Fundraising Committee, serving both Boards, meeting quarterly
- People & Governance Committee, serving both Boards, meeting quarterly
- Clinical Governance, Client Services & Safeguarding Committee, serving the Helen Bamber Foundation, meeting biannually

Asylum Aid is a wholly owned subsidiary of the Helen Bamber Foundation, functioning as an independent charity. Alison Pickup took up the role of Group CEO in August 2025. Alison acts as CEO of both charities and provides unified leadership across them, supported by an expert Management Group of senior directors leading key functions, including Legal, Therapy, Fundraising, and Policy & Research.

EQUITY, DIVERSITY AND INCLUSION

We are committed to attracting and recruiting diverse candidates because we are keen to make sure that all our staff, trustees, volunteers and ambassadors reflect the communities we serve and the wider community we work in.

We recognise and value the role diversity plays in good governance and genuinely welcome and encourage applications from a range of backgrounds, especially people of colour, people with disabilities, people from low socio-economic backgrounds, refugees, stateless people and others with lived experience of forced migration or trauma.

JOB DESCRIPTION

KEY RESPONSIBILITIES

Strategic direction and oversight

- To set the Helen Bamber Foundation and/or Asylum Aid's overall strategic direction
- To help define goals and evaluate performance
- To be responsible for the governance of the charity, ensuring that the charity acts in accordance with its governing documents and applicable legislation
- To support and advise the Executive on the vision, direction and management of the charity

Decision making

- To exercise control over the financial affairs of the charity and protect its assets, ensuring that the charity is financially sustainable
- To make decisions at all times in the best interests of the charity
- To attend and contribute to Board Meetings and any relevant Committee meetings

Responsibilities

- To ensure that the charity uses its resources exclusively to further its charitable objects
- To advocate on behalf of survivors and asylum seekers and refugees
- To raise the profile of the charity and act as an ambassador for the charity
- Provide ad hoc support to the CEO and Executive Team

Trustees have ultimate responsibility for directing the affairs of their charity, ensuring it complies with the law, is solvent and well-run and is delivering the outcomes for which it was set up and which have been agreed with funders. For more detailed information see the Charity Commission's website below and in particular the publication 'The Essential Trustee' (CC3). A small number of people are barred from serving as charity trustees and applicants will be asked to confirm their eligibility. TRUSTEE PERSON SPECIFICATION

All Trustees need to be:

- Committed to the Helen Bamber's Foundation and/or Asylum Aid's vision, purpose and values and able to act in a manner consistent with these
- Able to work constructively as part of a small team
- Able to think strategically and have sound independent judgement
- Open minded with a strong commitment to equality, diversity and inclusion and committed to shifting power to people with lived experience and upholding anti-racist practice at all levels

We are also looking for the following specific skills in our new Helen Bamber Foundation Trustees:

- Policy, advocacy, public affairs or strategic communications experience
- Clinical or therapeutic experience (as a practitioner or as an academic) and/or
- Expert human rights experience, ideally we are looking for a lawyer, former Judge or academic

We are also looking for the following specific skills in our new Asylum Aid Trustees:

- Lived experience of being an asylum seeker, refugee or having sought another form of humanitarian protection in the UK, or of statelessness and/or
- Experience in accounting or finance

We value and recognise the powerful insight that lived experience will bring to our Board of Trustees. However, we respect that people's identity is not defined by their lived experience and we do not expect people to describe their lived experience at any stage during this recruitment process or if appointed as trustee of Asylum Aid.

TERM LENGTH

Trustees are appointed for an initial term of three years. This may be renewed for a further three years by mutual agreement and subject to re-election by the Board. A Trustee may serve a maximum of three terms (nine years in total).

TIME COMMITMENT

Trustees are expected to attend quarterly Board meetings. These typically take place from 2-5pm at our Old Street Office (we can make provisions for Trustees to attend online as necessary). Dates are agreed in advance and at present are held on a Thursday. Each trustee brings unique knowledge, skills and experience which enhances the effectiveness of the overall Board. As trustees have a legal responsibility for the organisation, we expect them to attend all four meetings annually unless there are exceptional circumstances.

The majority of our trustees serve on one or more of our subcommittees. The subcommittees meet online between 2-4 times a year. Meetings normally last up to 2 hours.

There will also be one annual Strategy Day for Trustees and occasionally short, ad-hoc online meetings to discuss specific matters.

There will be some preparation needed before meetings so you are able to share your views and actively participate in discussions. Papers are usually circulated around a week before meetings.

SUPPORT WE WILL PROVIDE YOU

We are committed to supporting you, and offering you a warm welcome. We would spend time with you to understand your skills and aspirations, and would be very happy to talk about any support that would be helpful for you. We will also provide:

- A full induction and targeted training as required.
- Mentoring provided by members of existing board of Trustees.

We are able to meet trustees' reasonable out-of-pocket expenses in line with our expenses policy e.g. travel or carers costs, to attend board meetings where necessary.

HOW TO APPLY

If you would like to apply for the role of trustee for Helen Bamber Foundation, Asylum Aid or both, please submit your CV and a short statement. At the beginning of your statement please specify whether you wish to be considered for:

- 1. a trustee position with Helen Bamber Foundation;
- 2. a trustee position with Asylum Aid;
- 3. a trustee position with both boards but can only serve on one;
- 4. a trustee position with both boards and can serve on both.

Your statement should then address the following three questions:

- 1. What is the main thing that interests you about applying for this Trustee role?
- 2. What is the particular skill (or skills) you have that you feel would be beneficial to this role? Please relate your answers to (1) and (2) to the information in this pack about Helen Bamber Foundation and/or Asylum Aid and the trustee skills we are looking to fill.
- 3. Do you have any previous experience of working with a charity board in particular or supporting a charity in general? If you do, please let us know what this was.

The questions can be responded to in one of four different ways:

- 1. Written A4 (No more than 2 sides of A4)
- 2. PowerPoint (No more than 3 slides)
- 3. Audio recording (No more than 5 mins)
- 4. Video Recording (No more than 5 mins)

ELIGIBILITY CHECKS

Since our work involves the engagement and participation of individuals with lived experience, candidates will be required to undergo an enhanced DBS check if offered the role. We will also ask you for the details of two referees (if you do not have workbased references, we are happy to accept character references or references from any time spent volunteering).
